  - The curricula of every programme in Gujarat Vidyapith deals with the issues of professional ethics, gender, human values, environment, and sustainability. Professional ethics is taught at any level of research in the institution. Not only the technical aspects such as plagiarism seriously dealt with but also the more important social and ethical values are an integral part of the institution. The findings of the field research or area-specific research are shared with the communities and societies from where the data was collected.

- The Research Ethics Committee takes care of ensuring that professional ethics have been followed in the research.
- Gender and human values are part of every single programme of the institution. Most of the programmes offer one or more courses where the focus is gender sensitization. Apart from representation in the courses, the institution organizes gender sensitization programmes for its students throughout the year.
- Being a Gandhian institution, most of the programmes offer courses on the environment and sustainability. At the undergraduate level, 'Introduction to Environment' is a compulsory course. Many departments, such as Rural Economics or Microbiology, offer specialized courses on environment and sustainability

#### 2.2 - Catering to Student Diversity

### 2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

- The teachers of Gujarat Vidyapith assess the learning level of the students right in the Orientation Programme itself. As the programmes requires students to express themselves, it becomes easier to identify the learning level of the students. Apart from this, as the teacher-student ratio in Gujarat Vidyapith is ideal, the teachers are able to give personal attention to each and every student.
- The slow learners are given extra attention in the tutorials. Teachers also give customized assignments to such students to increase their learning level. Such students are also encouraged to meet the teachers whenever they face any problem. The advanced learners are given extra assignments of more crucial nature where they can exercise their critical faculties. Such students are also given stage during different programmes and competitions. Advance learners also present their work during the morning assembly sessions in their respective campuses.
- In order to ensure that students get holistic exposure, the
  institution organizes expert lectures of people who work in
  different walks of social life such as social workers etc. The
  insights provided by such people go a long way in opening
  students' outlook towards their own life as well as towards
  the social life.

#### 2.3 - Teaching- Learning Process

- 2.3.1 Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences
  - Different programmes adopt several teaching-learning methods such as field work, internship, project work, rural studies, educational trips, and exposure to real life work situations. All these components get equal weightage. Students of Rural Studies programmes learn some parts of their courses in the Krishi Vigyan Kendra which allows them to understand their courses in the real-life situations. Students of MBA learn pricing by making a product and sell it in the market. Students of Economics learn cooperative sector by working in a cooperative sector unit.
  - The students get ample opportunity for participatory learning by active engagement in hostel management, workshops, different camps etc. Hostels are managed by Hostel Management Committee which is manned by students only under the guidance of the warden. In the same way, NSS camps and Gram Jeevan Yatras are organized and managed by students only. All the programmes are video recorded by the students of Audio-Visual department.
  - Problem Solving: Final semester of each programme has a course on project work which focuses on theoretical problems in real life situations. This helps students to apply all their learning and understanding in problem solving.

- 2.3.2 Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year
  - The institution promotes the use of ICT-enabled tools for effective teaching and learning process. The challenges posed by Covid-19 pandemic have also promoted increased use of ICT

for online classes. During the entire pandemic, all the lectures happened online on Microsoft Teams platform. Other platforms include Google Meet. Many times, when both the platforms didn't work for some of the students, the teachers organized small WhatsApp video calls for interacting with the students. All the lectures delivered on Microsoft Teams have been recorded and have been stored on the platform for those students who could not join because of internet connectivity issues.

• Teachers also provided the students with official audio-video content related to courses. This also helped students to search the internet on their own in search of quality material which were then authenticated by the faculty members. Some teachers have their own YouTube channels where they posted their lectures online for the future generation of learners too. The IQAC issued advisory to the teachers to prepare online audio-video content of their own with the help of audio-visual department of the university. The plan is also afoot to ensure that enough material is available for online courses.

- 2.5.3 IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution
  - The institution is moving towards making the entire examination process paperless. Some of the aspects of examination system has been transferred to the online only such as filling up of examination form, publication of results, online application for convocation and e-processing of request for transcripts. This has ensured that less time is spent by the students and the administration in reading each form individually. The introduction of Academic Bank of Credits has also improved the system and brought it in tune with rest of the educational arrangement.
  - The institution is working on making the entire process machine-based so that the entire process can be quickened up considerably. The computer science department has been asked to develop an in-house system for the same. Also, the institution is thinking of developing the ERP system which will make the entire process paperless. This will also be helpful in implementation of NEP 2020. The institution is also giving training to the staff members in online attendance and examination management system so that everybody is ready whenever the system is read for being implement fully.

#### 2.6 - Student Performance and Learning Outcomes

- 2.6.1 The institution has stated learning outcomes (generic and programme specific)/graduate attributes which are integrated into the assessment process and widely publicized through the website and other documents
  - The institution has well-defined and clearly stated programme outcomes, programme specific outcomes, and course outcomes.
     The course outcomes are evaluated through continuous evaluation process and the semester-end examinations. The continuous evaluation includes assignments, seminars, debates, quizzes, and field assignments.
  - The evaluation process keeps in mind the course outcomes. The programme outcomes are analyzed by the entire departments. Whether a student has demonstrated all or most of the programme specific outcomes is seen in participation in different activities and programmes. This is observed over the course of six semester in the undergraduate level and four semester in the postgraduate level.
  - The generic programme outcome is assessed through the students' participation in the institutional activities such as community living and supporting other students, handicraft skills, sense and practice of cleanliness, and active participation in morning assembly. The students are evaluated during extension programmes such NSS camps and Gram Jeevan Yatra. These provide the scope to access whether the students have developed adequate level of empathy for the problems of the society and whether they are ready to do their bit to help the society.

- 2.6.2 Attainment of Programme outcomes, Programme specific outcomes and course outcomes are evaluated by the institution during the year
  - The institution evaluate programmes outcomes at the end of the programme (after 3 years in the case of undergraduate

- programmes and after 2 years in the case of the postgraduate programmes). These include evaluating students in their conduct during extension activities such as NSS camps and Gram Jeevan Yatras.
- The assessment looks into interpersonal communication skills, level of adaptability in adverse circumstances, and students' level of empathy for the poor and downtrodden of the society. The programme specific outcomes are evaluated every year as well as the end of the programme. It is done on the basis of students' performance across all the semesters and whether s/he has attained all the outcomes of the specific programmes. The course outcomes are evaluated every semester through continuous evaluation process and semester-end examination. These include critical thinking and reflection upon one's own actions.
- The marksheet reflect all these evaluations. It carries course evaluation as well as essential attributes of the graduates such as critical thinking, ready to work with communities, and level of empathy for all sections of the society.

#### INFRASTRUCTURE AND LEARNING RESOURCES

#### 4.1 - Physical Facilities

- 4.1.1 The institution has adequate facilities for teaching learning. viz., classrooms, laboratories, computing equipment, etc.
  - Among its three campuses, the Ahmedabad campus spans 27.65 acres, the Sadra campus encompasses 37.80 acres, and the Randheja campus spans 32.28 acres. The development of this infrastructure adheres to all regulations set forth by governing bodies. Fully furnished and well-equipped facilities include classrooms, seminar halls, computer labs, and faculty offices. Smart classrooms and an auditorium are utilized for hosting special programs such as seminars, workshops, symposiums, co-curricular and extra-curricular activities. The institute has incorporated modern technology into the teaching-learning process and has established 65 Technology-Enabled classrooms/halls equipped with LAN/Wi-Fi capabilities and LCD projectors.
  - The central library of Gujarat Vidyapith is situated in the Ahmedabad campus, boasting a comprehensive collection exceeding 6 lakh books, including volume sets, rare texts, and reference materials. The Microbiology laboratory is well-equipped with state-of-the-art research equipment. Each campus is equipped with a well-appointed computer center for academic and research purposes. All three campuses are connected via a wireless internet network.
  - The two rural campuses also feature lecture and prayer rooms that are adequately furnished, well-maintained, and suitably equipped. Within various academic blocks, there are a total of 7 halls that serve dual purposes for seminars and community prayer, all being appropriately furnished, well-equipped, and maintained.

  - In terms of sports facilities, Gujarat Vidyapith excels in providing a comprehensive range of opportunities. The campus boasts dedicated grounds for outdoor sports such as kabbadi, kho-kho, cricket, badminton, basketball, volleyball, handball, and netball. Additionally, a state-of-the-art auditorium, gymnasium, and open stadium at the Sadra campus elevate the students' competitive edge. Indoor sports like tennis, carom, and weigh-lifting find a well-equipped home. A specialized sports laboratory for fitness and wellness testing adds to the resources.
  - Regular cultural events, sports competitions, and government physical examinations are part of the institution's routine. A dynamic physical education and Yoga department, guided by highly trained instructors, motivates students with an array of sports and top-notch equipment. The Yoga Centre, Gym, and Swimming Pool further enhance students' well-being.
  - An auditorium in Ahmedabad accommodates 750 attendees, utilizing an innovative earth cooling system for comfort. The Sadra and Randheja campuses also feature auditoriums with 750 and 500-plus seating capacities, respectively.
  - Cultural activities promote leadership, teamwork, and personal growth, and Gujarat Vidyapith actively hosts cultural events and contests throughout the year. Multipurpose halls and facilities for departmental-level cultural events, yoga, indoor/outdoor games, and sports support students' mental development, as well as faculty engagement. The institution's commitment to holistic education shines through its comprehensive facilities and opportunities.

- Gujarat Vidyapith boasts a guest house equipped with essential amenities, including a conference room, dining hall, Wi-Fienabled, ACand Non-AC rooms, and a rest area. Canteens offer nutritious breakfast, lunch, and dinner to visitors.
- All campuses are equipped with natural water coolers, and banking and ATM services are conveniently available. Solar rooftop facilities generatingelectricity are integrated into the Ahmedabad campus's. Khadi products are readily accessible to students and teachers. The institution maintains its fleet of buses and vehicles for academic, research, and outreach activities. To promote inclusivity, campuses feature ramps, lifts, disabled-friendly restrooms, and wheelchairs for differently-abled individuals, ensuring their mobility and comfort.

#### 4.2 - Library as a Learning Resource

## 4.2.1 - Library is automated using Integrated Library Management System (ILMS) and has digitisation facility

- The library at Gujarat Vidyapith boasts an extensive collection exceeding 600,000 items, encompassing books, reference materials, copyrighted works, children's literature, rare books, manuscripts, and journal volumes. To efficiently manage its daily operations, the institute implemented an integrated library management system called 'SOUL 2.0,' developed by INFLIBNET (IUC-UGC). Initially, the library used an in-house software system based on the Sybase Database, later transitioning to 'SOUL 1.0.' Subsequently, the library successfully migrated its data to the upgraded 'SOUL 2.0' version. Presently, the library is fully automated using SOUL 2.0, with all items barcoded for streamlined book issuance and return processes, including user membership cards.
- The library also houses an in-house digitization facility lab, established with the support of INFLIBNET Centre. This lab features a server, nine high-end PCs with scanners, and internet connectivity. It has been instrumental in digitizing over 500 theses, making them available on both the institutional repository and the Shodhganga platform. Furthermore, the library previously collaborated with the Centre for Development of Advanced Computing (C-DAC) to digitize more than 32,000 books. Additionally, the library possesses digital copies of 627 rare manuscripts and over 800 documents related to Gandhian literature.

- 4.4.2 There are established systems and procedures for maintaining and utilizing physical, academic and support facilities laboratory, library, sports complex, computers, classrooms etc.
  - The Estate Departmentis responsible for the maintenance of all campuses and buildings, supported by a maintenance workforce that includes plumbers, pump operators, electricians, carpenters and etc. Major repairs and maintenance projects are overseen by the engineering office through contracts with external contractors, while smaller projects are managed inhouse.
  - Security personnel and non-skilled employees are outsourced, with limited contractual commitments, responsible for the upkeep of classrooms, guest houses, grounds, seminar and prayer halls. The central library is staffed with librarians and support personnel responsible for its operation and the availability of instructional materials. The computer department, USIC, and system personnel handle in-house maintenance of personal computers, vital software, and peripherals across various Gujarat Vidyapith departments.
  - There is no AMCfor ICT assets, and cost savings are achieved through the "learning by doing" initiative.
  - In the Science Department, laboratories are managed by teachers serving as lab in-charges, along with Lab Assistants & attendants. The Physical Director oversees sports facilities and equipment distribution according to activity schedules. Fire extinguishers are strategically placed throughout the structures, ensuring safety.
  - A dedicated network and system management team ensures internet connectivity and maintains the CCTV security system, complemented by recruited security personnel to safeguard the entire facility.

Some of the committees are sports & games committee, cultural committee, broadcasting committee, literary committee, health committee, morning assembly committee, NSS committee, etc. These committees are responsible for organizing day-to-day activities of the campus and special programmes during the entire year.
- The committees members are also responsible for reporting any problem faced by any student to the concerned authorities. Regular meetings are held to discuss the problems faced by the students as well as to understand the kinds of programmes need to the done for the betterment of the students. The student council provides different platforms to the students to showcase their skills and talents in different kinds of activities. Although Covid-19 pandemic did not allow much scope for active participation of the students, still some activities were organized following safety protocols. The students council also organized sessions for students to help in spreading awareness regarding Covid-19 pandemic in their own village and localities

### 5.4 - Alumni Engagement

5.4.1 - The Alumni Association/Chapters (registered and functional)contributes significantly to the development of the institution through financial and other support services during the year

- Most of the departments of Gujarat Vidyapith have their own alumni associations. Some of them, such as computer science, and social work, are registered whereas most of the associations are unregistered. Alumni members are actively engaged in the activities of the department through their suggestions in the framing of syllabus and their financial contributions. As many of the alumni members are employed in the corporate world, they give feedback on the kind of skills and knowledge systems required in the market. In this way, they work as a bridge between the institution and the market requirements. This feedback is given orally whenever they visit the department.
- Alumni also give financial contributions towards the fees of the existing students. The alumni association of social work has earmarked a sum of Rs. 20,000/- each year for helping those students who face financial difficulties in paying their fees. The alumni association of microbiology gave important tips to the students in dealing with Covid-19 patients and also the laboratory testing procedures during the pandemic. Alumni of computer science and life long learning held many online programmes to impart relevant professional skills to the existing students.

- The leadership in Gujarat Vidyapith is dispersed at multiple levels. The Vice Chancellor is the head of the institute whereas the registrar acts as a head of the administrative setup. But no decision is taken without the participation of teachers at each level.
- The Departmental Advisory Committee (DAC) consists of every teacher in the department. The HoD cannot take any decision without putting it first in the DAC. Similarly, each HoD represents the opinion of the entire department at the level

### 6.2 - Strategy Development and Deployment

### 6.2.1 - The institutional Strategic plan is effectively deployed

- The institution decided to fulfill all the criteria for going into the NAAC cycle 2. As the institution got the new registrar (I/c) and vice chancellor in June 2021, it was imperative to acquaint them to the existing state of things. The VC held numerous meetings with the coordinator of the IQAC to fill up all the backlog of AQARs and go for the NAAC Peer Team Visit by the end of the academic year 2021-22.
- A team of 14 members was constituted. Each of the seven criteria was divided into these members and these seven small teams were tasked with the writing of the AQAR of academic years 2018-19, 2019-20, 2020-21, and rewriting of AQAR of academic years 2016-17 and 2017-18 as per the new format. This step was completed by August of 2021 and the IIQA was submitted.
- With the acceptance of LoI by the NAAC, the team gathered again in the month of December 2021 and January 2022 and put together the entire SSR and submitted it by the end of January 2022. It was the strategic deployment of relevant human resources in the IQAC which ensured the completion of SSR within a couple of months.

### **6.3 - Faculty Empowerment Strategies**

- 6.3.1 The institution has a performance appraisal system, promotional avenues and effective welfare measures for teaching and non-teaching staff
  - Gujarat Vidyapith has designed and implemented 14 different kinds of appraisal forms for various categories of staff members.
  - Annual Performance Appraisal Reports (APAR) are collected from the staff members after the end of every financial year. These reports cover all aspects of the work as well as the living environment of the institution. An employee is expected to fill in the form and submit it to the immediate superior. For instance, a teaching staff's APAR will go to the respective HoD and then to the Dean of the faculty and then to the coordinator of the campus.
  - After their comments, the final authority is the vice chancellor for the teaching staff. The final authority for nonteaching staff is the registrar. The APAR with all the comments and signatures is then sent back to the respective employee by e-mail within six months of the submission by the employee.
  - The promotional avenues for the teaching staff are CAS and direct recruitment according to the UGC norms. The promotional avenues for non-teaching staff are as per the rules of DoPT.

### 6.4 - Financial Management and Resource Mobilization

### 6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

- Majority of the students of Gujarat Vidyapith are from economically deprived communities. The education fees and hostel fees are kept at a minimal level so that students do not have to leave their studies mid-way.
- To instill a sense of independence and pride among the students, the institution also offers Swabhiman Scholarship where students are given some manual work on the campuses for around 30 hours in a month. Students are paid at the rate of Rs. 40 per hour. The monthly emolument covers their food bill.
- Students also work in the institute during the summer vacation where they work for 8 hours every day, and they earn upto Rs. 16000/- which is enough to take care of their education and hostel mess fees.
- The institution rents out its properties such as seminar halls and canteen facilities to other organizations for nominal fees. The fees are used for the upkeep of the institutional properties.
- The institution also receives donations from individual donors for giving awards and honours to the students. These are given to the students during the convocation ceremony. During the

### 6.4.4 - Institution conducts internal and external financial audits regularly

- Gujarat Vidyapith carries out internal and external financial audits regularly. All the bills for payment are audited internally before the payment. Another internal audit is done after the payment. The internal audit of the institution is carried out by the accounts department of the institution twice in a year. The next step is a statutory audit which is done by a Chartered Accountant (CA). Any quarry raised during these audits are answered by the Registrar and the accounts department of the institution.
- From the year 2003 onwards, the office of the Accountant General (AG) of Gujarat also audits the financial matters of the institution. If there are any discrepancy in the accounts, AG sends half-margin paragraphs to the institution seeking explanation. Such objections are taken up by the Registrar and

the accounts department who provide explanations. These explanations are also tabled in the appropriate bodies of the institution. If the AG is satisfied with the response, the objection is dropped otherwise the matter is reported to the office of Comptroller and Auditor General (CAG) which in turn seeks clarifications from the institution. These clarifications are provided by the Registrar.

- 6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes by constantly reviewing the teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals
- 1. Focus on generation of audio-video learning materials Learning from the situation created due to Covid-19 pandemic, IQAC advised all the members of the teaching staff to ensure that they should record their lectures and make it available to their students through social media. This would ensure that students have sufficient learning material in the form of such lectures. IQAC also invited teachers to come up with online modules which can be hosted on the recognized platforms such as UGC-CEC or NPTEL. IQAC also decided to advise the Academic Council to pass the resoultion that 40% of the courses in any programme can be done on MOOC. 2. Decentralized course work for the PhD students IQAC decided to decentralize the course work progamme for the PhD students. The departments were given autonomy to decide on how to conduct the course work related to different courses. The IOAC also made it known to the departments that going by the PhD regulation, students are free to not opt for the discipline-specific courses. The only course which IQAC will continue to conduct the course on Research and Publication Ethics.

- 6.5.3 Incremental improvements made for the preceding during the year with regard to quality (in case of first cycle) Post accreditation quality initiatives(second and subsequent cycles)
  - Initiatives in the administrative domains: IQAC has been trying to make the administrative system quicker with the penetration of technology. It has been observed that the administrative staff is not well-versed with the Excel or calculation programmes in the PC. It requested the administration of the institute to organize a training programme for such officials. A 20-hour workshop was organized on the upgradation of the computer skills which are spread over two months. Every Saturday, an in-house resource person trained these officials in the effective and efficient use of computer tools.
  - Initiatives in the academic domains: IQAC decided to decentralize the PhD coursework where the departments were given the responsibility to conduct the courses on research methodology with respect to the specific discipline and the courses related to the discipline. IQAC also ensured the adherence of the MPhil and PhD regulations of the year 2018. PhD admissions were streamlined, and NET/SLET candidates were given exemption from the written examination.
